INGREDIENTS/CHEMICAL NAME : Aluminum Zirconium Trichlorohydrate Gly, Cyclopentasiloxane, Stearyl Alcohol, Dimethicone, Petrolatum, PPG-14 Butyl Ether, Hydrogenated Castor Oil, Talc, Fragrance*, Mineral Oil, Behenyl Alcohol. *Unscented product contains masking fragrance.

POTENTIAL HEALTH EFFECTS:
